WLMA REPORT

January has been mostly devoted to the auditing of every single boat on the lake. This is required every year for LA and Ventura County Tax Assessors. LA County follows up with their own assessor who comes out to audit each boat on the LA side. It is also an extremely necessary task for WLMA to complete at least once a year to ensure every boat is accounted for and all information is correct in the database. The hope is to use specialized marina based software that would show a real map of the lake while showing every boat and slip. At the click of a button, you can see who occupies that slip or dock and add or subtract boats accordingly. This is one of the many features this marina software offers.

January brought us a record rainfall and the lake held up well to the onslaught received. Most of the large branches and logs were gathered that flow into the lake from Potrero Creek. The water will remain brown for the next 4 weeks until the particles settle to the lake bottom and become sediment. Potrero Creek is still flowing and water continues to flow over the dam.

WLMA has purchased a custom net that will trap Carp when they try to swim up Potrero Creek and this usually happens at the end of February into March. There are hundreds of Carp that gather under the Triunfo bridge and the plan is to drop the weighted net under the dam with the electroshocking boats inside the net to shock the carp as they try to swim back into the lake. Many carp will be captured within days. Special thanks to the committee for spear heading this.

WLMA will be sending out letters this month to homeowners that have been chosen to receive an Aqua Thruster aerator on their dock. These are going to those that have poor water circulation in that particular area.

The clearing of deadwood from along the edge of the dam that borders Westlake Athletic Club has also taken place this month.

With this clearing, multiple drains from the Athletic Club were uncovered and the water coming out was undercutting the concrete of the wingwall of the dam. This has been corrected and the drains now flow over the wingwall.

Below are projects for 2023:

- Add Fob gate system to the marina dock gates.
- Apply Alum sulphate to the entire lake to maintain consistent clarity.
- Addition of Wells 3 & 4 to be functioning
- Update and replace signage around the lake and marina gates.
- Update marina & homeowner dock inventory software.
- Install Aqua Thruster aerators on selected inlets.
- Replace WLMA numbered registration tags on all boats to reflective stickers for easy night vision for lake patrol
- Replace address stickers on all homeowner docks with reflective tape.
- Add 24-hour camera surveillance on each marina dock to be viewed from office TV.
- Replace roof on WLMA office and strengthen structure of office foundation

On March 12, 2023, Sunday, daylight savings time officially beginn D to set your clocks forward one hour before you go to bed on Saturday night.

Local fire agencies recommend changing batteries in smoke detectors and checking your fire extinguishers when clock times are changed. In addition, check your emergency supply kit to make sure it is fully stocked and ready. Happy Spring!

SPRING CLEANING? GET RID OF CLUTTER IN AN HOUR OR LESS

Getting rid of clutter doesn't have to be a long, drawn-out process. You can complete this entire list of clutterreducing projects in an hour or less.

ARCHTECTURAL APPLICATIONS

The purposes of these Architectural Rules are to provide positive guidelines for the continuation of the harmony and beauty of our community while preserving the value of the investment that all of us have in Lakeshore. These purposes include:

- Avoiding problems involving changes that may affect the common areas, including views of the Lake.
- Preserving the congruous appearance, variety and individuality of Lakeshore's architectural integrity
- Considering the aesthetic and functional aspect of any design change(s).
- Minimizing oversights caused by owners or their contractors, who may be unaware of the needs and concern of the Association, community and neighboring homes.

Violation of these Architectural Rules could result in fines, suspension of privileges, and/or legal action for which you could be held responsible per CC&R § 1.33
